- b. Entire body must be in italics
- c. Font: Times New Roman, Size 12, Colour: Automatic, Alignment: Justified
- d. Portrait mode
- e. Line spacing: 1.5
- f. The Cover page shall consist of the following details: Title of the Paper, Name of the author(s), Official designation/institutional details, Address, E-mail Id and Contact details of the Author(s).
- g. The subject of E-mail for submission of Abstract must be "National Seminar: Submission of Abstract & Cover Page.
- h. There must be a single file containing the cover page and abstract.

- d. Line Spacing: 1.5
- e. Text alignment must be justified.
- f. Footnotes should follow uniform style of citation: Blue Book 20th Edition.
- g. Font size 10 is to be maintained for Footnotes.
- h. The Cover page shall consist of the following details: Title of the Paper, Name of the author(s), Official designation/institutional details, Address, E-mail Id and Contact details of the Author(s).
- i. The subject of E-mail for submission of Full Paper must be "National Seminar: Submission of Full Paper".
